### [01/09/2023 – Current] From Things to Bytes: Reimagining Ownership in the Data Economy

This project was funded by the Bolyai Research Scholarship of the Hungarian Academy of Sciences (September 2023–August 2024). It analyzes the legal status of digital data, focusing on private-law relationships and taking into account relevant EU legislation governing the data economy. While the study primarily adopts a property-law perspective, it also addresses related questions in contract law, law and economics, and legal theory. The monograph is titled From Things to Bytes: Reimagining Ownership in the Data Economy.
